Overview

Should the Guernsey insurance fund increase contribution rates?

The Committee for Employment & Social Security has submitted its annual contributory benefit and contribution rates Policy Letter, which recommends an increase to the contributory benefits funded from the Guernsey Insurance Fund and the Long-term Care Insurance Fund from January.

Does Guernsey pay Social Security?

Employers in Guernsey are required to pay social security contributions for their employees. These contributions fund the island's social insurance scheme, which provides benefits such as pensions, sickness benefit, and unemployment benefit. The rates and thresholds for contributions are set annually.

Will Guernsey increase pension rates?

"The Committee is proposing that the rates of the States pension and all other contributory benefits funded from the Guernsey Insurance Fund are increased by 4.9%, 0.4% more than the rate of core inflation for the year to June 2024.

Does Guernsey affect UK benefits?

Similarly, contributions paid in Guernsey will affect the level of benefit received in the United Kingdom. Note that there are similar reciprocal arrangements with other countries including France, Switzerland and the USA.

Who is eligible for social insurance in Guernsey?

Generally speaking, the social insurance scheme applies to all people in Guernsey, Alderney, Herm and Jethou who are over school leaving age. They pay contributions into the social insurance scheme so that they are entitled to receive benefits according to whether or not they worked and how they were employed.
