

BESS project financing options in Ireland 2026





Overview

Today, we are seeing non-recourse project finance for 600+ MW portfolios, mezzanine debt entering the capital stack, and public banks co-financing with private lenders. For developers, asset managers, and financiers alike, this is a call to sophisticate how BESS projects are packaged and financed. Which Bess projects are taking steps forward in Ireland?

Indeed, a number of BESS projects in Ireland have taken steps forwards recently as the sector expands, including NTR battery storage projects totaling 22MW securing ten-year contracts for the supply of grid capacity to the Irish grid system and RWE's largest battery storage project to date entering full operations in County Monaghan.

How will Bess work in Ireland?

Ireland is targeting a renewable energy mix of 70% by 2030 and the BESS projects will help to integrate more renewables on the grid. Frequency response services well-suited to batteries have made Ireland a relatively advanced market for battery energy storage relative to its size.

How many Bess projects are there in Ireland?

Currently, around 17 BESS are connected to the grid, with many more filtering their way through the planning system around the country. Over the past number of weeks, the Irish Farmers Journal has been contacted by a number of farmers who have been approached by developers looking to build BESS projects on their land. Land requirement.

Which energy company is launching a Bess system in Ireland?

Last July, Neoen Renewables Ireland Ltd, a French renewable energy company, announced a 149.6MW BESS on an 8.5ac site near Portarlinton, Laois. Just last week, the ESB opened a 75MW/150MWh BESS at the Poolbeg Energy Hub in Dublin. The system is Ireland's largest so far and is part of its €300m BESS portfolio.



How does a Bess project work?

BESS projects collect energy from renewable sources, such as wind and solar panels, or from the electricity grid, storing it in large battery storage units. These batteries release the energy back to the grid when needed – for instance, during peak demands, helping to balance supply and demand, and improve grid stability.

Which Bess projects are in the pipeline?

Two BESS projects are already in the pipeline, with a combined capacity of 8 MWh slated for Ireland and Scotland. These projects are expected to enhance energy resilience and support the integration of more renewable energy into the grid.
