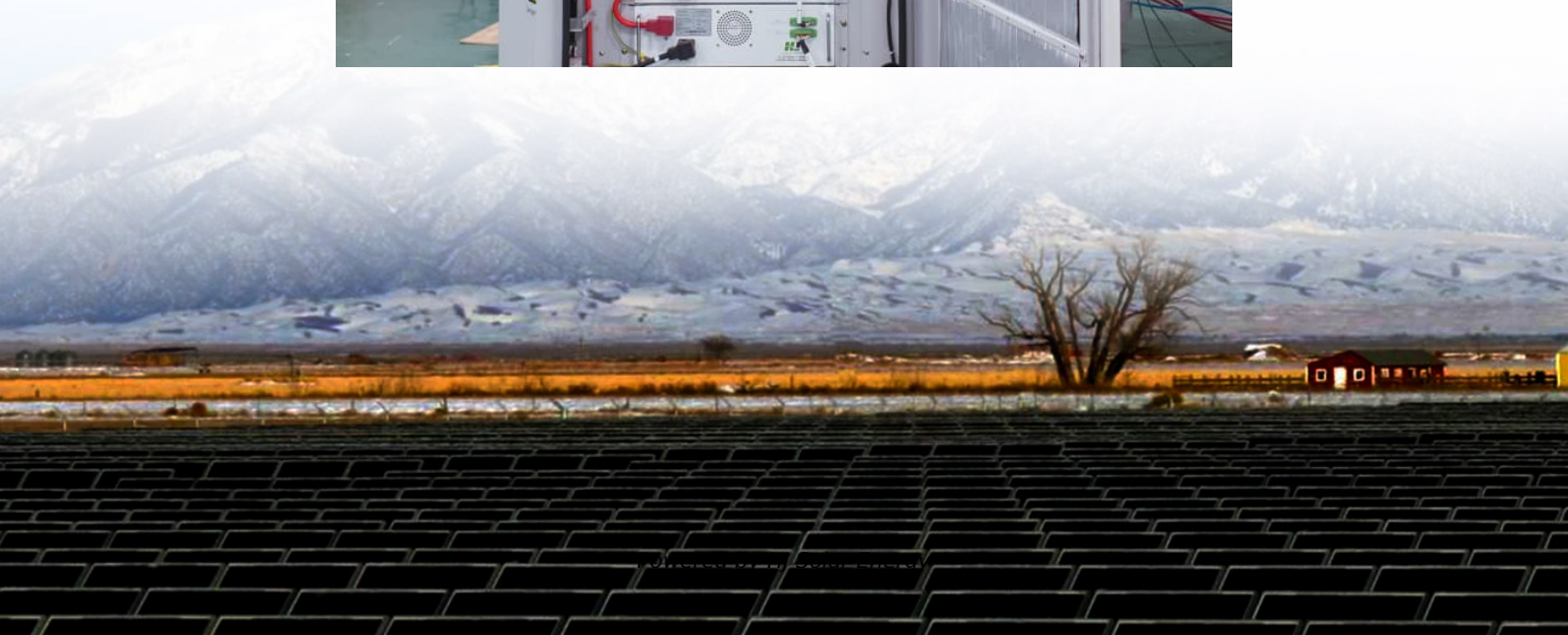


Enterprise ESS system cost vs benefit calculation in Kuwait





Overview

What are the end of service benefits in Kuwait?

Workers in Kuwait, who are paid on a daily, weekly, or hourly basis, are entitled to 10 days for each of the first five years of service and a 15-day remuneration for each year thereafter according to Article 51 of the Kuwait Labour Law. The total end of service benefit should not exceed one-year remuneration.

How do I calculate indemnity pay in Kuwait?

There are several online indemnity calculators available that can help you calculate your indemnity pay. Simply enter the required information, such as your length of service and last received wage, and the calculator will generate an estimated indemnity amount.

What type of indemnity pay do employees in Kuwait get?

Determine the type of indemnity pay the employee is entitled to: As mentioned earlier, employees in Kuwait are entitled to two types of indemnity pay: 15 days' pay for each year of service for employees who have worked less than 5 years, and 30 days' pay for each year of service for employees who have worked more than 5 years.

Can a company avoid paying Social Security benefits in Kuwait?

However, some organizations may attempt to avoid paying these benefits, which is illegal under Kuwaiti law. Both employees and employers contribute to the social security fund, and this should not be deducted from the indemnity.

Reasons for eligibility for end-of-service benefits: Kuwaiti workers qualify for



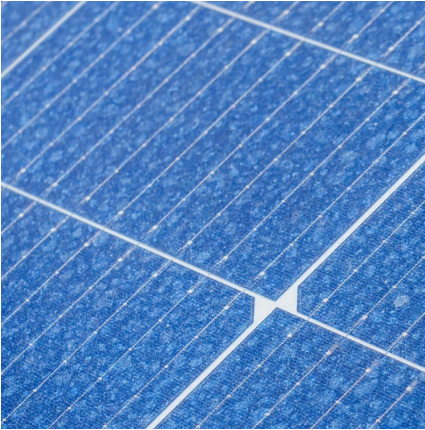
end-of-service benefits under specific circumstances: Duration of employment with the company. Worker's death. Inability to work. Extended sick leave beyond the allowed period. Employer's bankruptcy or company closure.

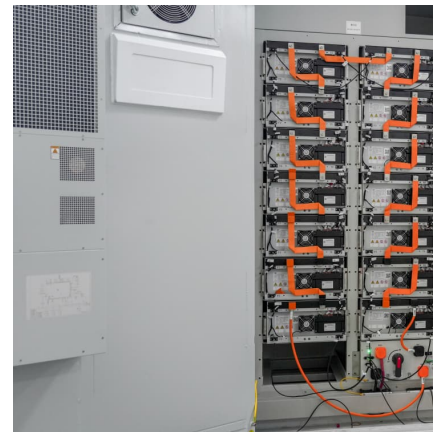

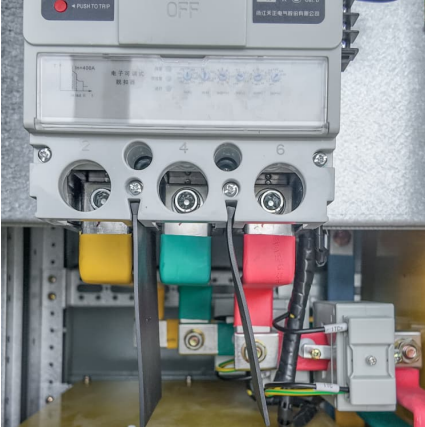

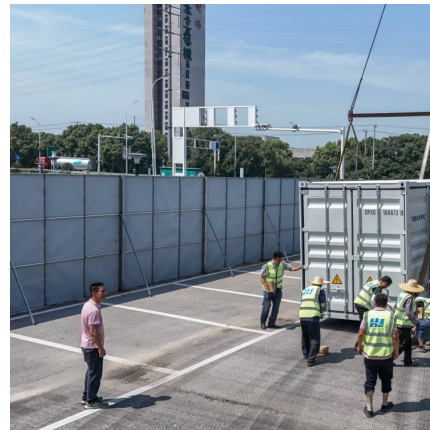
