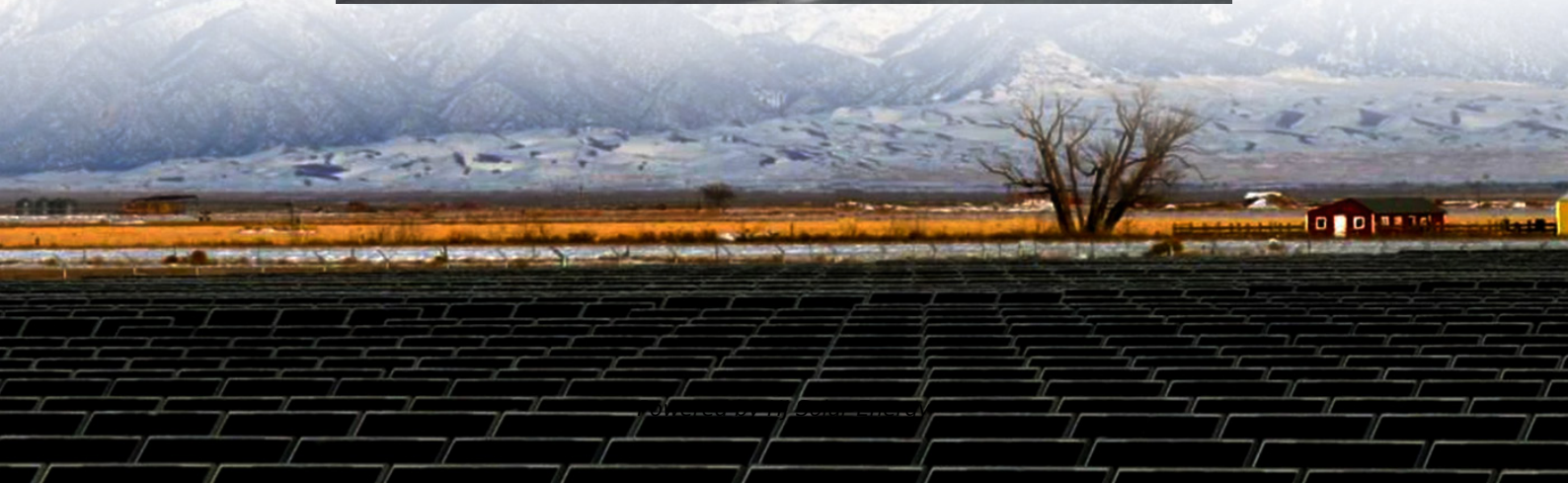

Argentina has awarded 667MW of battery energy storage system (BESS) in its first tender under the AlmaGBA scheme. Nearly half of the volume submitted for the tender (1.3GW) has been awarded by the wholesale market operator CAMMESA (Compañía Administradora del Mercado Mayorista Eléctrico Sociedad).

Contract prices settled between \$10,161 and \$12,815 per MW-month, comfortably below the reference price of \$15,000/MW-month set by CAMMESA, the market's administrator. This pricing dynamic signals both growing competition among developers and the increasing economic viability



of battery energy.

Although the Argentinian government has estimated that it will invest half a billion dollars of public funds, the project is being greatly supported by the private funds. The approved bidders will be getting a lesser-paid rate of 10/MW electricity supplied, and the bids in the energy storage.
