Essentially, the limit means that all batteries with capacities of 8.3 kWh and greater will qualify for a \$2,500 rebate. This covers most of the home solar batteries on the market.

Does Oregon have a solar & storage rebate program?

In 2020, the Oregon state government made \$10 million available for its Solar + Storage Rebate Program, which provides rebates of \$300 per kWh for



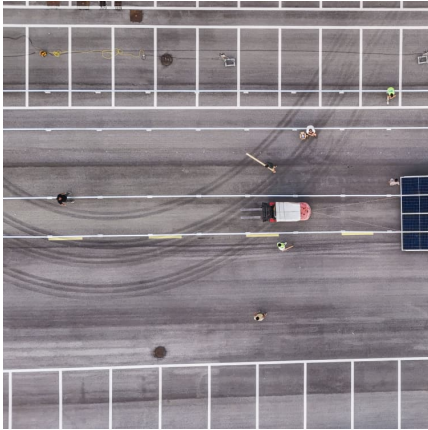
residential battery systems.
