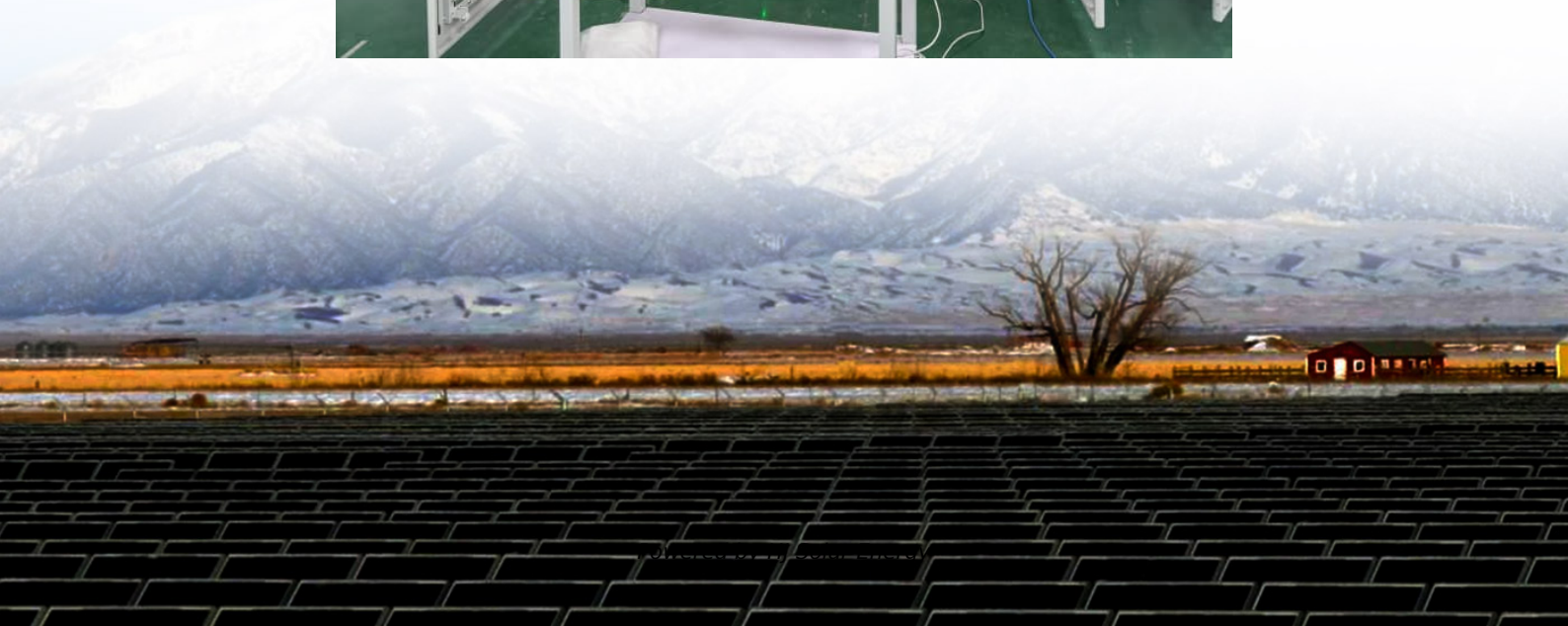


# Hong kong stock photovoltaic energy storage investment
