How much sick pay do employees get in Slovakia?

Employees in Slovakia are entitled to a maximum of 52 weeks of sick pay per year. Employers are responsible for sick pay for the first 10 days of absence, which is paid as per the following: If an employee is absent for over 10 days, employers must notify the Social Insurance Company so that the employee can claim sickness benefits.
