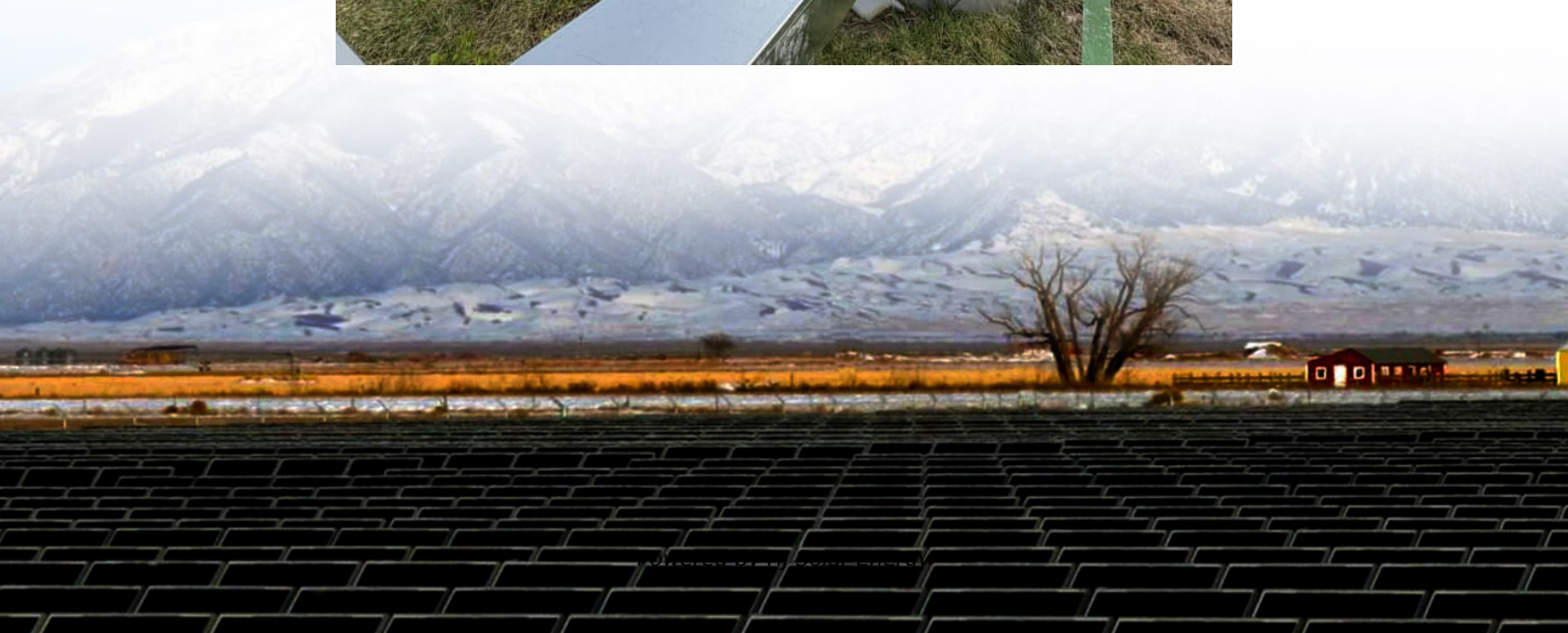

## Overview

---

Should oil storage facilities be regulated by EPA?

EPA recommends that facility owners or operators increasing existing storage capacity and/or creating new oil storage facilities should ensure the oil is stored in accordance with applicable federal Spill Prevention, Control and Countermeasure (SPCC) and Facility Response Plan (FRP) requirements.

What are oil storage regulations?

Oil storage regulations are designed to protect the environment and public health by ensuring that oil stored in tanks meets specific safety standards. These regulations are intended to prevent spills and leaks from causing harm to people or the environment. The regulations cover both onshore and offshore operations.

What is an oil storage advisory?

This advisory is designed to help owners and operators of new and existing oil storage facilities achieve and maintain compliance by better understanding federal regulatory requirements that may apply to their site. The assistance provided here focuses on Clean Water Act requirements, but other environmental regulatory requirements may also apply.

What are the benefits of oil storage regulations?

Following oil storage regulations can have numerous benefits for big and small businesses. For one, properly storing oil products is essential in avoiding accidents that could be costly and put human lives at risk.

What are the responsibilities of oil storage facilities?

In addition to outlining the technical requirements of oil storage facilities, these regulations also detail the responsibilities of operators who store various petroleum products. These include properly maintaining equipment and reporting any incidents related to the storage or transportation of petroleum



products.

Are oil storage tanks regulated?

Both the Occupational Safety and Health Administration (OSHA) and Environmental Protection Agency (EPA) have established regulations for oil storage tanks, which include requirements for tank design, containment systems, and emergency response plans. In general, oil storage compliance regulations address the following issues:

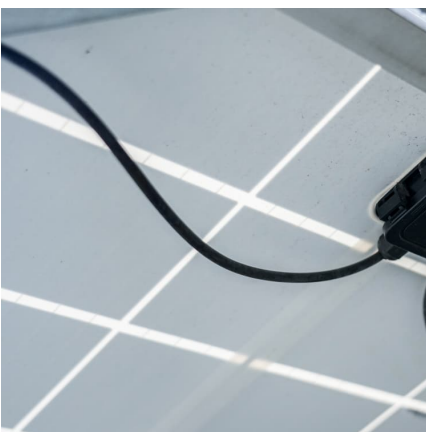
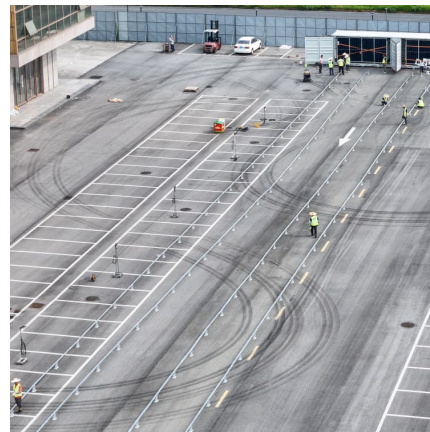

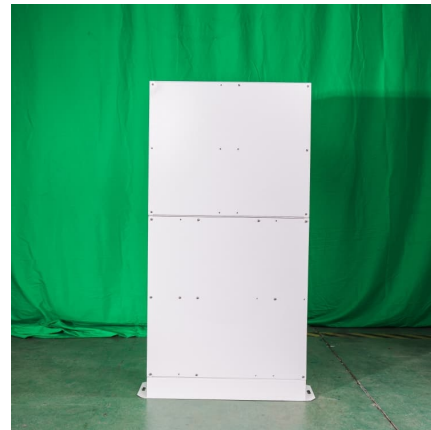
